Popup Tent Guide

We have suffered very extreme weather conditions this spring and summer. Please be reminded that pop up temporary canopies are water resistant and not water proof. As such, we encourage you to cover your merchandise with a protective tarp or plastic sheeting should we encounter severe wet weather, thunder storms or lightning.

Should we encounter severe weather, please use a broom handle or blunt handled instrument (to avoid puncturing the tent) to prevent water from accumulating on the roof of your canopy. Left unattended the water will eventually seep through the nylon fabric.

Please be reminded that your pop up temporary canopy is made of an aluminum superstructure. As such, you should refrain from hanging anything weighing more than 20lbs. from the cross bars or touching the aluminum frame in the event of thunder or lightning as the possibility exists for lightning strikes. (Albeit very remote)

Please be reminded that Higgins Event Rentals makes no representations as to the safety and security of your booth contents.

On show closing, please leave all rented materials in your booth space. Higgins crews will be by to pick it up at first opportunity. Please be reminded that the responsibility for the equipment rests with the renter until such time as it is returned to a Higgins crew member.
